## ABOUT YHELD

YHELD Project consortium was designed by a set of partners from universities in Yemen and EU, including universities that did not benefit from other calls of ERASMUS+. The Consortium involves eight Yemeni partners that have been chosen for their remarkable potential but not exploited in full yet.

The goal of the Yemeni Higher Education Leading to Development of relint offices project (YHELD) is to contribute to reduce the internationalization isolation of






Yemeni HEIs, promoting their role in the educational, cultural and economic actions for the reconstruction of the country.

The project responds to an urgent and concrete request formulated by Yemeni Universities to support them in overcoming some of the difficulties and the isolation problems created by the recent and current history of the PC. The higher education is one of the sectors that sustained serious destruction and is not considered as priority due to the humaniatarian emergency. In addition, the security issue as well as the lack of qualified employment opportunities have discouraged students to participate in the academic life. HEIs have a key role to play in social stability, international cooperation and peace-building actions, as well as in advocacy on these key themes with national and international stakeholders which are probably the only realistic and feasible actors able to support local educational Institutions and to improve government and international awareness on local educational needs.

The specific objective of the project is to enhance Yemeni HEIs capacities and abilities to work at international level, through the establishment of IROs – International Relation Offices and the definition of internationalization strategies in the partner Yemeni universities.

IROs will be academic window on international scenario, a strategic "tool" to involve local educational community in international innovative initiatives, giving visibility, supporting, and monitoring the Universities' initiatives also assuring good quality standards.

In order to achieve our objectives, we will use a multidisciplinary methodology that will allows us to approach the challenge from



different perspectives:

- Develop new innovative and multidisciplinary abilities to improve HEIs abilities and capabilities;
- Design a coordinate internationalization strategy for each participating HEI to make effective resources, activities and capacities;
- Create national and international network.

The project will last 24 months and it has been designed to balance the collaboration of all partners and the clear responsibility in the management of every single task. The consortium is composed by 8 Yemeni Universities, with a current small operational capacity, 4 EU HEIs, representatives of three European countries, and 1 EU Association of Universities.

In one hand partner country's universities see international link as a lifeline for their attempts to enhance and re-launch the quality of their academic disciplines by keeping up-to-date with international developments and this is the basis for the ownership of the project results. In the other hand, EU academic Institutions are fully committed in transfer know-how, experience and good practices to foster access to Yemeni youth to a qualitative higher education offer. Both are fully aware that modernized HEIs will not only transfer knowledge, but also will create social and economic values through the of their teaching transfer and research results to the community/country, and this is the challenge YHELD project would respond to.

The project comes from the agreement of different universities interested in reinforcing their capabilities and entering in network of cooperation. In fact, thanks to the Erasmus + program, some of the Country Partners have already collaborated with previous European projects and they are already active within the European Union networks understating the importance of international cooperation and visibility.



In the academic year 2007/08, SASS began implementing full-time study programs, namely the undergraduate study program Advanced Social Studies, which renamed into (academic) is study program Social Management, and the master's study program Intercultural



Management. In 2008, the School obtained accreditation for a doctoral program of Sociology, thus vertically completing the system of study programs, i.e. at the postgraduate, master's and doctoral levels.

#### UNIMED, the Mediterranean Universities Union

UNIMED, is an association of Universities from Mediterranean basin countries. It counts 140 associated universities coming from 23 countries of both shores of the Mediterranean (data updated in December 2021). UNIMED's aim is to develop university research and education in the Euro-Mediterranean area to contribute to scientific, cultural, social and economic cooperation. The network was funded in 1991 and operates since more than 30 years in



promoting the international dimension of universities; encouraging participation of its members in international projects; promoting mobility; organising meetings, seminars and roundtables both at national and international level; providing training for academic and administrative staff.

## **University of Abyan**

Abyan University, is a Yemeni government university located in Abyan Governorate, in the south of the Republic of Yemen. The university was established on the date of Jumada al-Akhir 6, corresponding 1439 AH, to February by 22, 2018, Presidential Decree No. (3) of 2018. It has a legal personality financially is and that administratively independent within the limits of the laws. regulations, and systems in force in the Republic. Abyan University contributes to the



preparation of qualified outputs through educational, research, training and advisory programs using modern and distinguished methods and means in accordance with quality standards and academic accreditation through efficient academic and administrative staff in light of an educational environment that stimulates creativity and optimal employment of technology and an effective local and external partnership and to be classified among the distinguished universities locally and regionally.

## **University of Aden**

University of Aden, is the first Yemeni university, established in the Republic of Yemen alongside the University of Sana'a. The establishment of the College of Higher Education in 1970 AD Nasser College and the of Agricultural Sciences in 1972 AD is the main link for the launch of the University of Aden, as these two colleges were subject to the Minister of Education. In 1973, the Faculty of Economics was established, and each faculty constituted administrative an unit. When the need arose to



establish another number of colleges, a ministerial decision was issued to form a ministerial committee for the university city, headed by the Prime Minister. It took over the preparation of the law establishing the university, and on the tenth of September 1975 AD, Law No. 22 of 1975 AD was issued regarding the establishment of the University of Aden as a scientific institution with a legal personality. The law defines the University's objectives as follows: preparing and qualifying scientific cadres in various disciplines; carrying out scientific research to serve social and economic development.

# **Al-Adel University**

**Al-Adel University**, has a great impact on the economic and social growth of Yemen as it ranks number 17640 in the world for its impact in Yemen country and World at large. The institute operate in an open way, as it ranks number 7420 in the world for its openness operations. Al Adel University is one of the renowned academic Yemen. institutes in The University has conducive environment which enable all students around the globe and Asia to join it for their future



prosperities. Offers various programmes ranging from Certificate, Diploma, Undergraduate Bachelor Degrees, Masters and more courses are likely to change depending on the needs of the people and their desired courses.

## Hadhramout University

Hadhramout University, was established by the Presidential Decree No. (45) of 1993 . It in Mukalla City, the locates of Hadhramout capital Governorate and it has several faculties in the cities of Mukalla, Al Ghaydah in Al Mahrah Governorate and Socotra. The study in HU began with the courses Bachelor in the academic year 1995-1996 by the inauguration of the three faculties which are: Engineering and Petroleum, Women's Faculty and Education Faculty / Seiyun.



In the academic year 2019-2020 the number of faculties reached to fifteen, in addition to five research centers, University Advisory Center and a number of service and training centers such as: the University Hospital, HU Family Medicine Center and the Model University Kindergarten.HU is a member of the Arab Universities Union and Federation of the Universities of the Islamic World. HU president was chosen as a member of Executive Office of the Union in the 5th session of the union.

# **Taiz University**

Taiz University, is in the city of Taiz, Republic of Yemen. It is one of the public universities operating under the supervision of the Ministry of Higher Education and Scientific Research. Taiz University was established at the beginning as a branch of the Faculty of Education at the University of Sana'a in 1985-1986. After that, it became an independent 1994-1995. The university in university different faculties has among the others: arts, applied sciences, engineering, information



technology, medicine, health sciences, administrative sciences, law, and education. It also consists of different centers such as the Center for Languages and Translation, Educational Rehabilitation and Development Center, Computer and Information Technology Center, Research Center, Feasibility Study Center, The Center for Distance Learning and the Center for Continuing Education and the Environment Center. Currently, the main objective of the university is to increase the quality of education for different faculties through the Quality Accreditation Authority to be able to graduate skilled people capable of dealing with different sectors civil society and rural communities towards sustainable development of the country.

# CONCLUSION

Discussion on project's idea started already a long time ago, when LCU and UNIMED discussed with some partners possibilities of follow-up of their projects.

The idea of the project was developed during some informal meeting among members in which PC Universities presented their needs and EU partners represents their commitment in Middle East area and in supporting the reconstruction and dialogue process in Yemen. Experiences from other Capacity Building projects were taken into account and all partners provided feedback on original project idea to the Coordinator. LCU has examined the possibility to bring the collaboration between the Institutions, and, as coordinator of the consortium, designed the frame of the project and shared each components with its members, that actively contributed in the proposal development.
